Committee Reports

Finance/Fundraising Committee Report – Tina Frantz, Committee Chair Committee: Shannon Lee, Andrea Markham, Wendy Hay, Judy Hagerman

In the spring of 2023, we held a Fashion Show fundraiser, using Board members, staff and community volunteers as models. We have not held this event since Covid-19 forced the cancellation of the event in 2020. It was fabulous to hold in-person events throughout the year. The June Art Auction, held both on-line and in person, culminated with an event at the Madoc Arts Building. We held the 4th Annual Golf Tournament at the West Highland Golf Course in August. We have also been blessed with very generous donations from our community.

In a Statement of Operations, our excess revenues over expenses was \$54,167, mostly due to the high gas tax rebate. Discussions regarding efficiency strategies have moved us toward considering the purchase of a Digital Transit Platform, as well as researching the purchase of a new vehicle. We are grateful for our continued support from Hastings County, our local 5 Municipalities, the Province of Ontario (gas tax rebate) and United Way Hastings Prince Edward, allowing us to continue to provide these much needed services within our community.

The Food Bank renovation, including a wheelchair accessible entrance and washroom were completed in June 2023. This project was completed thanks to a generous donation by the Parrott Foundation, fundraising events and donations. We held an Open House in July for the community to view the new Foodbank space.

Thanks to Sally Gale, Executive Director and Judy Hagerman, Finance Officer for guiding us through this financial year. A special thank you to Kim Clarke, Board Director, for her extensive work on the Food Bank Renovation Project.

CHSN remained committed to providing convenient, affordable transportation within our rural setting. The On-Demand Transit Model has seen an outstanding increase in our ridership. The Transit Committee met four times this year. The Transit Committee proposed to the Board in February that we update our cell phone policy and that we hire someone to assist with bookings. Brooke Berry was hired and has been such an asset in assisting with our booking process.

Our ED and EA travelled to Toronto for the Ontario Transit Expo, an excellent opportunity for our staff to network with the other Transit providers and discuss best practices. Our ED visited each of the five Municipalities to discuss the new on-demand service started since COVID. We reinitiated our Transit Partners Group and had a very successful meeting with the supportive Mayors and staff from 3 of our partners to improve communication and encourage all to keep Public Transit in their budgets.

We thank Hastings County, the United Way HPE and our 5 Transit Partners -Municipality of Centre Hastings, Madoc Twp., Marmora and Lake Twp., Stirling-Rawdon Twp., and Municipality of Tweed.

Personnel Committee Report – Shannon Lee, Committee Chair Committee: Andrea Markham, Tina Frantz, Wendy Hay

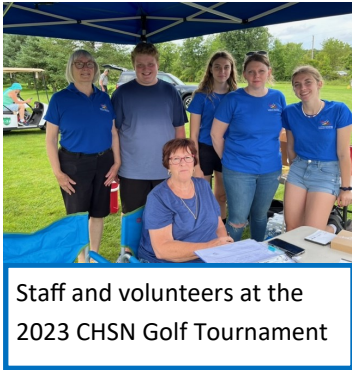
